Pinellas County E-NEWS

The following information was provided by the Pinellas County Marketing and Communications Department. Following Hurricane Irma, coordinated debris collection continues for residents in unincorporated Pinellas County. Debris contractors began storm debris collection from county rights-of-way on Monday, the week after the Hurricane.

The crews are working on the debris pickup seven days a week. Residents are asked to place debris in sorted piles at the public right-of-way for curbside collection by debris crews. Residents are also advised to contact their regular garbage hauler to have it picked up.

Residents are asked to not place debris in trash bags. Debris will be collected and taken to a temporary storage site to ultimately be recycled or disposed of.

Residents are asked to sort debris by item type and place in separate piles. These are the specific items that can be moved to the curbs side for collection:
