Please be sure to include your Hilcrest Manor address on the check. Although dues are voluntary, your contribution helps to show your interest in our neighborhood, and it will help us **pay** for items approved in the budget at the last annual meeting. As we grow the paid membership our goal is to reduce the yearly amount and to fund community events like BBQ's and best lawn contests.

As you may or may not know, being a board member is a 100% voluntary position. Our number 1 priority is maintaining a vibrant, happy and prosperous community. In order for our community to be all these things it is paramount that we all work together to abide by our deed restrictions. If everyone followed our deed restrictions, then there would be nothing to enforce! We trust that when there's a violation, it is more likely that the person didn't know it was wrong, so we want to do our best to improve communication and education of these restrictions, So you know, the deed restrictions can be easily downloaded from our website hillcrestmanorhoa.org. For most of us our home is our number one financial asset. Keeping our community and homes in good condition will ensure our homes continue to increase in value.

## Things to Be Aware Of.

Here are a few restrictions that often get overlooked that really hurt our home values and give our community a negative perception.

Poor landscaping and unkept yards (Deed Restriction 13)

- Leaving trash receptacles on driveways or in front of their garage doors (Deed Restriction 18: "The driveway [...] shall not be used as a staging area between trash service days.")
- Parking in the grass median instead of in the street (Deed Restriction 23)
- Inoperable vehicles, including boats and cars, and unregistered cars cannot be parked in the street or driveway (County Enforcement Code Sec 58-270)
- Parking of commercial vehicles 1-ton or more cannot be in driveways or street regardless of writing on the Vehicle (County Enforcement Code Sec 122-37).
